AIKTC-CIIIRD Exit/Graduation Strategy

Incubating companies will leave the incubator under the following circumstances: They may altogether exit from AIKTC- CIIIRD or graduate to move into other locations on commercial terms prevalent at that time.

- Stay at incubation center can be up to **two** years. Based on the work progress, it may be extended by a maximum of **one** more year.
- Raising substantial investment from angel investor / Venture Capital Fund / any other investor—Rs. 2 crores or more.
- Underperformance or un-viability of the business proposition: criteria for the same will be decided and applied by **AIKTC- CIIIRD** on the case to case basis.
- When the number of employees of the company exceeds 50.
- When the annual gross revenues of the incubate company (excluding all the taxes) exceeds Rs. 2 crore.
- Change in promoters'/ founders' team without concurrence of AIKTC-CIIIRD
- When the company enters in an acquisition, merger deal or reorganization deal resulting in a substantial change in the profile of the company, its promoters, directors, shareholders, products or business plan.
- Any change of more than 50% of equity ownership unless approved by AIKTC- CIIIRD
