The meeting was started in hybrid mode with the permission of Dr. Ramjan Khatik (Director, AIKTC & Chairman IQAC) at 2.30 pm. Few members of IQAC joined the meeting via zoom meet online platform. Holy verses of the Quran by Prof. Saad Shaikh, (Member IQAC).

With the permission of the Director, and Dr. Rajendra Magar (Dean, SoET & Jt. Chairman IQAC), Prof. Arif Iqbal Shaikh (Coordinator IQAC) started the session by welcoming all the members of IQAC.

Coordinator IQAC started the discussion as per the set agenda points as follows:

#### 1) Approval of minutes of the meeting (held on 14 June 2023) and ATR:

Prof. Arif Iqbal Shaikh read the minutes of the meeting and ATR. The same was accepted by all the attendees. The approval of the NAAC sponsored seminar is still pending from NAAC office. The seminar was expected to be held on 3<sup>rd</sup> February 2023. Also, the centres were given targets as per the benchmarks given by NAAC. Dr. Magar- Dean SOET said the academic audit is completed effectively, on time, and in the format specified. Registrar added that the audit of administrative section is going on.

#### 2) Status of Submission of AQAR 2022-2023:

The submission of AQAR work is still going on and that will be completed by December 2023. There are very few metrics that are pending from departmental coordinators and that needs to be processed for AQAR uploads.

#### 3) Preparation of Cycle 2 NAAC Assessment:

As NAAC cycle 1 certification about to expire, a meeting on microplanning is to be scheduled between 15 to 20 January 2024. IQAC second meeting of the academic year to be kept in the month of March 2024.

#### 4) Conduction of Alumni Meet:

An alumni meet is to be conducted on 9 December 2023. The preparation is already started. Favourable response has received from alumni. The centre for Alumni Connects shall be coordinating the entire activities.

#### 5) To decide on an action plan for maximum enrolment for NPTEL courses:

Dr. Magar appreciated Dr. Rohan on doing good job as the NPTEL SPOC. There are many faculty members received certification with Elite, Gold and Silver: 5 (E+G), 26 (E+S), and 39 (elite). Mr. Vedant Bipin, a student representative made recommendations about financial assistance to students on NPTEL certification examination too. Prof. Arif Iqbal requested the Executive Chairman to approve for financial assistance policies for NPTEL and MOOC courses to students as well.

#### 6) Planning of FDPs, and STTPs by various schools and departments:

Prof. Arif Iqbal pointed out the need to increase faculty development programs.

Dr. Magar, each department should design one FDP and one STTP for the year 2024. By December 23rd, EE and CE were already scheduled. CE (two days FDP): complete station remote sensing on December 27, 28, 2023. The centre for Human Resource Training and Development to schedule training programs for non-teaching members.

#### 7) Academic calendar & Activity Calendar for even semester 2023-24:

Introduction of the activity calendar was provided by Prof. Arif Iqbal and its importance in planning and execution of the activities. A checklist will be released by IQAC. The same to be utilized for making an activity calendar at the school and departmental level. Mr. Burhan Harris appreciated the need of this initiative.

#### 8) To finalize the Vision-Mission statements of IQAC-AIKTC:

Each school and department have already finalized their vision and mission statements, a need was felt to formulate vision and mission statements for IQAC. Keeping in mind the vision and mission statements of the institute and statements provided by NAAC following statements is accepted by the attendees.

#### 9) Any other matter with the permission of the chair:

Mr. Burhan Harris chairman of the institute asked all stakeholders to have OBE completely into practice.

Dr. Magar stated that the entire academic audit is based on OBE. Soon we will be going for NBA accreditation for eligible programs. Awareness about OBE is to be created amongst non-teaching by taking awareness session.

Dr. Magar asked Mr. Pawar for recommendations. Mr. Maruti Pawar emphasized the value of industrial training (industry/practical expertise). Management should support this initiative. Mr. Pawar promised to always be there for the AIKTC students and shared a few of his life stories to help them develop key fundamental qualities.
